Trustees Teresa Acree, Jay Trusner, Kourt Mooney, Kevin Vessels, Les Jenkins, Budget Officer Rick Laskowski, Attorney Andrew Weatherford, Clerk Penny Allen and Mayor Evelyn Deverell were present. Visitors

Darla Coit-7440 W. Wood-discussed an issue in her neighborhood. In a residents backyard, location Twin Lakes/Main Street -there is industrial equipment being stored there; dump truck, industrial truck, paving equipment. People at this residents leave at 6 am everyday and more staff keeps appearing. This is a residential neighborhood and a business should not be allowed. She thought there were ordinances to so this did not happen. When she looks out her back door, this is all she can see. There is normally 2-3 dump trucks, machine on a trailer, and rock being dumped there. Trustee Mooney questioned Mayor Deverell how many complaints have been received regarding this. Mayor Deverell stated this is the 3rd formal complaint.

Mayor Updates

Project 6899 water improvement/tower/IEPA loan-construction to date – Water tower painting and electrical is complete. Decatur interconnect pump station has been delivered and water mains connected to it. Contractor is working on running power to it. Chemical feed vault is installed at new water tower site and chemical feed building is set. Water main has been installed to the chemical feed vault for new water tower.

Suburban Street Jurisdictional Transfer-request to IDOT to address the lack of language for the future ownership of the right a way. Waiting on their direction

MFT Drainage- waiting on the jurisdictional transfer

Caldwell Tank-received an affidavit from Mr. Russell. A resolution will need to be passed; the village is the only one that can issue a variance. Attorney Weatherford will get one drawn up.

Jonathon Closs is concerned about our water. He said we currently produce about as much as we use a day. How are we going to fill up the new water tower? Could wait until coop is up or use Decatur water. He said they tell him we have to flush our entire system out if we use Decatur because Decatur is service water from a lake and ours is ground and each is treated two different ways. Ron Legnor said may have to process a time extension to Caldwell if we want to fill when coop is on line. Need to make a decision by next meeting in case have to process a time extension. Jon will get a second opinion regarding Decatur water.
