Cathcart Auction-auction will be held on August 21. They asked if anyone wanted to do concessions there. (On Williams Street) Janice Endrizzi, Aubie Endrizzi and Evelyn Deverell will have a stand and all proceeds will go to the Veterans Memorial Fund. Most everything has been donated for this.

#### **Budget Officers Report**

BO Rick Laskowski discussed. Trustee Larry Ditty arrived at 7:18 pm. Motion by Jay Trusner to approve the Budget officers report. Trustee Mooney  $2^{nd}$ . Approved 5-0

#### Engineer Report

Project 6899-Water improvement/tower/IEPA loan-water tower erection is complete. Painters are scheduled to start anytime. Decatur interconnect pump station drawing have been reviewed and station is in production. Burdick is planning to set chemical feed vault at new water tower. The water tower work is expected to be complete by end of November.

MFT/ Drainage-IDOT has approved the design contract and the plans have been started. Hope to have at the next meeting – does not require board action.

Suburban Street Jurisdictional Transfer-the Village ordinance accepting responsibility for the roadway has been sent for IDOT review. When IDOT approves the language, the Village can move forward with the final roadway acceptance.

An email was sent to Caldwell to see if everything has been submitted regarding the Illinois hiring issue; no response yet. Attorney Weatherford requested for Mr. Legner to send all the emails to him also

MS4 permit- for storm drainage – phone calls made to get better answer where Decatur MS4 area ends. No response yet

Gouge Rd Easement-last conversation with the new owners seemed receptive. They are to get back with Mr. Legner in 2 weeks.

America Recovery Plan- anticipating the Village will be getting \$ 175639.92. Forms need to be filled out on line to receive this. Money can be used to replace loss revenue, invest in sewer, premium pay for essential workers and other items.

Mayor Deverell suggested options

- start working on lagoons aeration system -this would not be enough money, would have to borrow money
- 2 find out where storm water is coming from flow study
- 3 2<sup>nd</sup> water line rehabilitating old water tower

Money must be spent within 2 years. Mayor requested the board members to think about this

Trustee Jay Trusner questioned the purpose of the 2<sup>nd</sup> water line. Is it really necessary? Mayor Deverell said we only have one now and it would be nice to have two. Trustee Trusner stated if we don't need it, why waste the money. If we are able to isolate and use our existing towers and Decatur water, is this really needed? Board is to think about this issue

#### Public Works

Jonathon Closs, public works supervisor, discussed the monthly report.

Trustee Kourt Mooney wanted to note that he has received many positive feedback on Mr. Closs' work.

Sale of Equipment- Mr. Closs suggests taking the bucket truck and the wood chipper to Martin Auction center and to place ad in newspaper, accepting sealed bids, for the old air conditioner and furnace from the old village hall. Mayor Deverell formed a new committee composed of Trustees Trusner, Mooney and Jenkins to look at new trucks for the village public works department. Would like to purchase a 4 wheel drive F350-450 or 550 with a snow plow. Could also be used as a service vehicle. Motion by Trustee Teresa Acree to approve/appoint the recommended committee to assist in the purchase of a truck and snowplow. Trustee Ditty 2<sup>nd</sup>. Approved 5-0. Motion by Trustee Mooney to authorize Jonathon Closs and the committee to spend up to \$40,000 for the purpose of obtaining a 4 wheel drive heavy duty truck and snow plow.
